Cost to attend is \$8 per adult and \$5 for children 12 and under. Contestants will have free admission.

They'll start the night with a dance number choreographed by Pam Rowden of Starlight Dance Studio. Members of the Pilot Club of Scott County will be on hand to help the girls as they compete. Pilot Club members have organized the annual pageant for many years.

Queen candidates will model their professional attire as well as beautiful formals each has selected for this important contest. They'll also be answering impromptu questions on stage.
