Queen Brooklyn was crowned at the conclusion of the annual pageant, which this year had attracted 14 competitors for the 2008 tiara. Judges had a difficult time deciding who was going to claim the crown, even leaving their table for a final consultation among themselves backstage before declaring Brooklyn the new Queen.

They also finally came to a conclusion on the 2008 Fair Princess title. They selected Kylie Ann Amick for that honor. But first, Kylie was declared 2008 Miss Congeniality, an honor decided among the contestants themselves.

"Wow! I am so surprised and pleased. I've very happy to be Fair Princess and Miss Congeniality. These girls are great!" declared Princess Kylie after the contest.

Queen Brooklyn and Princess Kylie were congratulated by their fellow contestants and then posed patiently for dozens of photos taken of them and 2007 Miss Scott County Aarika Hutton as well as with parents and well-wishers.

Each girl who participated answered three questions on stage that evening so that judges obtained by the sponsoring Pilot Club of Scott County could get an idea of their personalities and how quickly they could respond.

The third question was fun for the girls. Each was asked how they'd spend \$20. Several said they'd buy treats for their fellow contestants. The final question-and-answer broke some of the tension of the evening, but nothing could really help, the girls clasping hands while the winners were announced.
