A total of \$61,685.85 was earned by 4-H'ers who entered their animals in the annual 4-H Livestock Auction on Friday evening, July 16, at the Scott County fairgrounds.

The crowd was in a good mood that night and delighted to honor several 4-H'ers who reached the end of their ten-year career in the Scott County program.
