First, the 2012 Miss Congeniality was announced. This young lady was selected by the girls entering this year's competition, and is honored for her friendly and out-going personality. Miss Congeniality is Bailey Nicole Jeffries.

Tall, blonde Laura Ashleigh Rogers, 2012 Fair Princess, was spotlighted next. Should the new Queen be unable to compete at the 2012 Miss Indiana State Fair Pageant in August, Fair Princess Laura will step up and participate.

Though there was no nerve-stretching drum roll, tension was certainly in the air, and then, all eyes were on Nicole Walker, the 2012 Fair Queen. Surprise and joy flooded her face as dozens of cameras flashed and she was assisted with her crown, cape, flowers and trophy by 2011 Miss Scott County Elizabeth Stivers.
