

## **?Golfers raise nearly \$2,300 for United Way Community Care Fund**

Almost \$2,300 was raised by 47 golfers during the United Way of Scott County's sixth annual golf scramble held on Sunday, September 27.

Third place went to last year's winners, John Newmister, Dick Stark, Darrel Day and Ransum Caldwell, who also scored a 58.
