

## Final spring primary election ballots set; some early candidates opt out

The noon deadline on Friday, February 7, set for those people who wished to run for public offices on either the Democrat or Republican tickets on May 6 was apparently met by all who aspired to such seats.

And the Monday, February 10, noon deadline to withdraw a candidacy was also observed by that same group.

County Clerk Missy Applegate, whose office is charged with conducting both primary and general elections in such years as offices become available, released the final listing of candidates. Readers will note some changes on both parties' slates.

In the Democrat Primary, incumbent District 4 County Councilman Clara Adkins withdrew her candidacy in late January. Her brother, Raymond Jones, promptly filed for the seat. Jones had held the post for eight years prior to his sister's winning the Council seat. Jones will be facing newcomer Josh Stigdon in the Democrat Primary.

In that same race on the Republican Primary ticket, April Reams Ramoni withdrew her candidacy. That action leaves Christopher "Chris" Albertson as the undisputed Republican candidate.

A filing by Teresa Vannarsdall, current County Auditor, for the District 3 Commissioner's seat raised political followers' eyebrows on Friday. Vannarsdall withdrew her candidacy before the Monday noon deadline. Had she stayed in that contest, she would have been the third candidate for the seat to have filed. District 3 is currently represented by Mark Hays. Tex Murphy has also filed for the seat as has Steve Phillips on the Republican side of the ticket.
