Hostess Brittany Banister, a member of the sponsoring Pilot Club of Scott County, first announced the contestants' selection of the 2009 Miss Congeniality winner. That honor went to Tia Monique Deaton. 2009 Fair Princess was announced next, and that title was given to Lisann Renee Goodin.

Tension mounted as the final announcement came and, to judge from her expression when her name was announced, Morgan was overwhelmingly surprised as Queen Brooklyn approached her with her new regalia.

Queen Morgan is the 18-year-old daughter of Leslie and Kevin Means of Scottsburg. Her sponsor in the competition was the Phi Beta Psi Sorority chapter of Scottsburg.
