The following are the minutes of the Pekin Community Betterment Organizations regular meeting, which was held Sept. 19.

The meeting was called to order at 7:05 pm at the Pekin Park Shelter House by President Anita Temple.

The Pledge to the Flag was led by Lois Greene. A prayer was said by Steve Burnett.

Mary Bell made a motion to accept the minutes of our last meeting after they were corrected. Brenda Fitzpatrick seconded the motion. The motion carried.

Treasurer Brenda Fitzpatrick reported a balance of \$23,335.77. She also reported the earnings on activities of the year as follows: Safari Bicycle Ride \$1775.51, 5K Walk/Run \$451.26, Queen Contest \$42.50, Prince/Princess Contest \$354, Carnival Rides \$245, Food Vendors \$1919.60, Flea Market \$2059, 3 on 3 Basketball \$120.76, Program Book \$7111.50, Pekin Idol (-\$205).

Gene Lewellen brought up some concerns about the Fourth of July Parade. He felt that everyone who comes to be in the parade should be considered as a trophy winner whether they preregistered or not.

He also questioned how a person who did not ride in the parade could be a trophy winner. Gene thought the move to line up the parade at the Eastern High School parking lot was an excellent one. He recommended that the entries be lined up farther back in the parking lot. Having the walkers line up at the church parking was also an excellent plan.
